He stated this funding is coming from a grant, the money just needs to be moved to the correct budget line before the grant's expiration on August 31st.

Legislator Albano questioned what the design change is.

Deputy Commissioner Lipton stated originally, they were going to add a side wall, which would require a single bracket with four (4) screens. He stated they are now going to expand the existing wall, which requires more brackets on each side and bottom to mount the screens.
