Budget Focus

Develop a fiscally responsible budget that provides for the health, safety and quality of life of our residents while not exceeding the tax cap







Summary of Proposed Budget

- Proposed 2015 budget \$145.4m
- A net increase of \$2.5m over 2014 adopted budget or a 1.75 percent increase, staying within our tax cap
- General Fund Surplus allocation of \$2.85m
 Our third straight budget using less surplus than the previous year







Bottom Line To The Taxpayer

The average homeowner assessed at \$261,219 will pay \$989 in 2015, an increase of \$13

As per the NYS Property Tax Freeze
Credit Legislation eligible Putnam
County Home Owners will be entitled to
a refund in the Fall of 2015








2015 Budget Revenue

- Revenues: \$145.4m
 - Sales Tax \$54.7m
 - 2015 Property Tax \$40.6m
 - Department Revenue \$17.3m
 - General Fund Surplus \$2.85m

Washington and Albany mandate \$103m in expenses but only reimburse Putnam County \$28.8m, which is 20% of the total revenue





2015 Tentative Expenses







Fiscal Strength and Integrity

Use of General Surplus Funds to Balance County Budget



Over the current administration's 3 years of crafting County Budgets the reliance on general fund surplus has been substantially reduced by 40%.

The 2015 County Budget for bond payments are slightly less than the 2012 County Budget bond payments.







- While the Counties around us had their bond rating DOWNGRADED, Putnam County remains SOLID and has been for the last 3 years of our administration
- Putnam County continues to have a strong bond rating which enables us to borrow at a lower interest rate
- Moody's credit rating is considered a
 County's report card and our grade is: Aa2







A Closer Look at MANDATED Programs

- New York State and the Federal Government
 MANDATE more than 200 programs
- Total cost to Putnam County Taxpayers: \$103.3m
- The \$103.3m consumes the entire Property Tax Levy
- It also consumes the vast majority of Putnam County Sales Tax Dollars!
- In fact 71% of the 2015 Budget goes to support
 MANDATED Programs!





Fiscal Responsibility "One Army on the War on Addiction"

- In the United States the cost to society due to Substance Abuse and Addiction:
 - Illegal Drugs 181 Billion Per Year
 - Alcohol 185 Billion Per Year
- It is estimated that 25% of each Medicare dollar and 20% of each Medicaid dollar are spent on Addiction Related Illness or Conditions





Fiscal Responsibility "One Army on the War on Addiction"

- In Putnam County
 - Narcotics Enforcement Unit (NEU) 2015 Budget
 \$1,608,246
 - Heroin Arrests Since 2012 have increased 300%
 - 40% of the inmate population at the Putnam County Correctional Facility were arrested by the NEU
 - In 2013 42% of NEU arrests were heroin or opiate related
 - To date in 2014 47% are heroin or opiate related







Social Responsibility "One Army on the War on Addiction"

In Putnam County

- 13 of the 21 children currently in foster care are there as a result of their parents alcohol & substance abuse
- 4 children had their own substance abuse issues
- 28 families received Preventative Foster Care Services as a result of alcohol or substance abuse







Fiscal Responsibility "One Army on the War on Addiction"

In Putnam County

- In 2012, total cost of Medicaid expenditures for Putnam Medicaid eligible residents (+/- 6,000) was \$95,796,553
 - \$5,586,751 was spent on mental health treatment (736 residents)
 - \$1,164,846 was spent on chemical dependency services (237 residents)
 - This does not include those who may have developed medical problems or have been injured as the result of alcohol or substance abuse







Social Responsibility "One Army on the War on Addiction"

- In Putnam County
 - These numbers don't reflect the social & emotional impact to the families and friends of those suffering from addiction
 - Physical illness
 - Devastating loss of a family member or friend to:
 - Suicide
 - Accidental overdose
 - Long term health effects due to alcohol and/or substance abuse







Fiscal Responsibility "One Army on the War on Addiction"

- In Putnam County
 - The Sheriff's Department had 152 arrests for DWI/DWAI in 2013 and 101 to date for 2014
 - Time expended for each arrest = approximately 4 hours
 - At 152 arrests for 2013 this equals 608 Man Hours lost or \$35,331

That's 608 hours lost providing neighborhood security, responding to Fire & EMS calls, etc.







Social Responsibility "One Army on the War on Addiction"

Early Education & Awareness Is Part Of This Campaign And We Are Bringing It To Our Schools

- SIDNE Program Shows the risk of drugs and alcohol while driving
- Too Good For Drugs classes given by Prevention Educators through Putnam County Funds



Both programs are being facilitated through the Putnam County Youth Bureau

Putnam County Drug Treatment Court

County Court Judge James F. Reitz

- Currently there are 87 active participants
 - 34 DWI cases
 - 41 Opioid dependent (pills/heroin)
 - 12 other drugs
- 14 additional individuals are in various stages of becoming participants

Respect For Our Veterans

- Veteran's Residence is at 100% occupancy
- The Putnam County Veterans Service Agency Director and Deputy Director are currently taking training that will allow them to become Certified Veterans Administration Officers
 - This will allow our underserved veterans to access the services that they are entitled to and deserve







Budget Drivers

- √ \$979k was budgeted to meet the salary increases for the Sheriff Union (PBA) and CSEA Union who have been working without a negotiated contract since 2011 (PCSEA and PuMA Negotiations Pending)
- √ \$395k was budgeted to meet increased health insurance premiums
- √ \$348k was budgeted for new positions (7.5 FTE's), most of which is focused on funding our campaign "One Army on the War on Addiction"

- Example
 - Working with the Transportation Division at the Planning Department, one PILOT Intern Project focused on completing a mandated Federal Transit Administration (FTA) review
 - Previously this would have cost the County \$109, 618
 - Instead, we used 5 interns at a cost of \$14,560
 - We saved over \$95,000







Managing Our Assets & Optimizing Our Resources Inmate Court Appearance

- Video Conferencing System Used For The First Time In 2014
- \$254,000 Spent For Prisoner Transport In 2013
- \$238,000 Budgeted For Prisoner Transport in 2015
- Installed In 3 Town Courts
 - Carmel, Southeast, Patterson
 - Reviewing Plans For Other Towns
- Supported By Administrative Judge Alan D. Sheinkman, County Court Judge James F. Reitz, Sheriff Donald B. Smith, District Attorney Adam Levy, The Legal Aid Society, The Putnam County Bar Association, Towns of Carmel, Patterson & Southeast

Managing Our Assets & Optimizing Our Resources

Continuing Our *Private Public Partnership*

Butterfield Project

- The successful creation of Butterfield will transform an existing deficient piece of property that will:
 - Create 70 permanent jobs
 - Create 80-100 temporary construction jobs
 - Increase the property tax base for Philipstown, Cold Spring, Haldane Central School District and Putnam County thereby reducing the tax burden of the remaining taxpayers - \$597k gross (conservatively ~ \$431k net of anticipated expenses)
 - Creates opportunities to generate additional sales tax; which ultimately enables Putnam County to reduce future property tax levies - ~ \$300k







Optimizing the Utilization of Our Resources

Continuing Our Private Public Partnership

Putnam Golf Course

- Increased Golf Rounds = Increased Revenue
 - 4.5% Increase From 2013 (30,088 rds vs 31,436 rds)
- Increased Tournament Activity = Increased Revenue
 - 36% Increase From 2013 (22 vs 30)
- Increased Catering & Events = Increased Revenue
 - o 76% Increase From 2013 (119 vs 210)
 - 1 Wedding in 2013 vs 8 in 2014
