Re: March 31, 2025 Memorandum: "Schedule Agriculture Farmland Protection Board Meeting"

Chair Sayegh:

I am in receipt of your March 31 memorandum titled "Schedule Agriculture Farmland Protection Board Meeting."

The Agriculture and Farmland Protection Board is an advisory adjunct to the county Legislature, whose duly elected members appoint the Board and recommend their terms. There are currently two vacancies on the Board, including the Board's former volunteer chair who was removed by the Legislature's Chair on New Year's Eve last year without any communication with the County Executive's Office.

I include that December 31, 2024, legislative memo for your convenience, where it states: "Please note that the power to appoint and/or remove from the Board remains with the Legislative Chairperson and Ms. Apicello always has the opportunity to express her interest to a future Chair." To date, these vacancies still have not been filled by the Legislature.

The New York State Agriculture and Markets Law goes into more detail: "The chairperson of the county legislative body shall appoint to it two qualified persons for terms of two years each, two qualified persons for terms of three years each and two qualified persons for a term of four years. Thereafter, the appointment of each member shall be for a term of four years [italics added]." Section 302 (1)(b). Other members of the Agriculture and Farmland Protection Board include the Commissioner of Planning, Development and Transportation, the Director of Real Property Taxes, and the Soil and Water District Manager. These individuals are on the Board, not by Executive appointment, but by virtue of their position in the County, in compliance with the New York State Agriculture and Markets Law Section 302(1)(a).

To assist in clarifying any misunderstandings, the Putnam County Agriculture and Farmland Protection Board is a non-executive body; my office has no independent authority to declare, announce, or otherwise schedule a meeting by Board members. That said, I am pleased to share with you and all Board members, copied on this memo for convenience, that I am already on record supporting, even encouraging, the Agriculture and Farmland Protection Board to meet in 2025.

I shared this publicly at this office's "Future of Farming Roundtable" held on March 21 in Putnam Valley. All members of the Legislature were invited, but only four of the Legislature's nine members chose to attend and observe the discussion. Fortunately, it was recorded and has been published on the County's website for all to see (accessible at: <a href="https://www.youtube.com/@putnamcountygov/videos">https://www.youtube.com/@putnamcountygov/videos</a>). If you have not done so already, I recommend reviewing the video so that you can listen to its participants from the state Farm Bureau, Cornell Cooperative Extension, Westchester and Dutchess counties, in addition to both current and former Putnam County Agriculture and Farmland Protection Board members. The roundtable offered wide-ranging views on what future steps our county may take to update its 2004 Farming Protection Plan, Agricultural District, Agricultural Assessment Program, and other policies to reflect or incorporate the best practices of our neighbors. Personally, I found it very helpful.

I hope that this explanation clarifies the issue.
