**Item #8) Discussion/NYSAC & District Attorneys Association/Request State Legislation to Reimburse Counties for District Attorneys Increase (bill #: S7408A/A10512-A)**

Chairwoman Nacerino stated the State mandated that the district attorneys receive a salary increase and this mandate was not reflected in the 2016 State Budget. She stated there is a bill before New York State Senate and New York State Assembly that would require the State to reimburse the counties for the district attorney salary increase. She stated she would like to

move forward with this matter by sending letters to our State Officials regarding New York State Senate Bill S7408A and matching New York State Assembly Bill A10512A.

Legislator Castellano and Legislator Wright stated they would support sending letters to the State Officials regarding the Bills.
