Item #6b – Approval/ Replace Resolution #50 of 2002/ Personnel/ Military Leave was next. On behalf of the members of the Personnel Committee, Legislators Nacerino and Sullivan, Legislator Jonke moved the following:

Legislator Jonke explained that this policy supports our Putnam County employees who also serve in the military. It makes up for their loss of income while they are away serving our Country.

Legislator Nacerino believed this was a wonderful policy and she thanked the individuals in the Personnel Department who proactively worked to revise this resolution to make sure these employees serving are made whole.

Legislator Sayegh explained that after the terrorist attacks on September 11, 2001, this policy was passed by the Legislature six (6) months later in March of 2002.

Chairwoman Addonizio stated that she was proud to support the updated version of this resolution. She thanked the Personnel Department for streamlining this policy.

RESOLUTION #141

APPROVAL/ REPLACE RESOLUTION #50 OF 2002/ PERSONNEL/ MILITARY LEAVE

WHEREAS, it is the policy of the County of Putnam to support those of its employees who volunteer to protect the United States against threats to our Country and vital national interests; and

WHEREAS, as a consequence of the terrorist attacks on September 11, 2001, upon the Pentagon Building in Washington DC and the World Trade Center in New York City, the County of Putnam passed resolution #50 of year 2002, in anticipation that employees of the County of Putnam who are members of the Armed Forces Reserves or National Guard may be called to active military duty, and

WHEREAS, under New York State Military Law Section 242, such employees are eligible for paid leave of thirty (30) calendar days or twenty-two (22) work days, whichever provides the greater benefit to the employee, in any calendar year or continuous period of absence, while performing ordered military duty; and

WHEREAS, the period of ordered, active military duty may exceed the paid military leave provided for under the New York State Military Law; and

WHEREAS, it is the intent of the County of Putnam to amend and extend Putnam County resolution #50 of the year 2002, ensuring that such employees be made whole, and are not penalized by the economic impact of their service to our nation; now therefore be it

RESOLVED, that subject to any applicable agreement by and with the respective collective bargaining agents of the various employee units of the County of Putnam, the compensation and benefit policies of the County of Putnam for its employees who are members of the Armed Forces Reserves or National Guard, who are called to active military duty, shall be as follows:

- 1. Such employee ordered to active military duty for a period exceeding the paid military leave provided for under New York Military Law, section 242, shall receive from the County of Putnam, a salary equal to the difference, if any, between the employee's County salary and the salary paid for the performance of such ordered military duty;
- 2. The term salary for the purposes of payment of the salary differential, is defined as base pay plus longevity and any other payments that are applicable to such employee pursuant to the appropriate bargaining unit agreement (i.e. education, credit payments, clothing allowances, etc.)
- Payment of the salary differential by the County of Putnam shall be subsequent to the receipt by the Department of Personnel of the County of Putnam, of documentation of payment received by the employee for said ordered military duty;
- 4. Payment of the salary differential by the County of Putnam shall not exceed two hundred sixty working days (260) every five (5) years with respect to each eligible County of Putnam Employee;
- 5. During the time an eligible County of Putnam employee is receiving the salary differential, such employee shall continue to receive all health benefit coverage, including dental and vision, where appropriate, and subject to applicable contribution rates, which such employee would otherwise be entitled if he or she was not called to active military duty, for such employee, the employee's spouse and other dependent as if such employee was in continuous attendance of his or her employment;
- During the time an eligible County of Putnam employee is receiving the salary differential, such employee shall continue to accrue vacation and sick leave credits, as if such employee has been in active employment of the County of Putnam for said period;

- 7. During the time an eligible County of Putnam employee is receiving the salary differential, such employee shall continue to be credited the appropriate number of personal days as per their collective bargaining agreement, as if such employee has been in active employment of the County of Putnam for said period;
- 8. All employee benefits shall be made available on the same terms and conditions as such benefits would otherwise have been available but for such employee's military activation;
- 9. During the time an eligible County of Putnam Employee is receiving the salary differential, the County of Putnam shall report the employee's earnings to the New York State Retirement System, however, these earnings will be considered non-pensionable as per New York State Law. The employee may then request service credit from the New York State Retirement System and pay any requisite service credit payment, and be it further

RESOLVED, that this resolution shall replace resolution #50 of 2002 passed on March 5, 2002; and be it further

RESOLVED, that the Personnel Officer and the Commissioner of Finance and their respective departments are hereby directed to undertake such administrative acts and tasks as are necessary and proper such as the creation of policies and/or procedures to carry out the intention of this resolution; and be it further

RESOLVED, that this Resolution shall take effect immediately

Legislator Castellano stated that the County is doing a great job and you can see the change over the last few years. He stated that we will continue to do the right thing for the people of Putnam County.

Chairwoman Addonizio explained that just recently solar panels were installed at the Kern building. She stated that several other county facilities will follow.

RESOLUTION #143

APPROVAL/ "GREEN INFRASTRUCTURE" AND "COMPLETE STREETS" PROGRAM/ CLIMATE SMART COMMUNITIES PROGRAMS / EXECUTIVE ORDER NO. 1-2021

WHEREAS, it is Putnam County's goal to continue a "Green Infrastructure" and "Complete Streets" program as an integrated system that protects the environment and reduces the consumption of fossil fuels; and

WHEREAS, the "Complete Streets Program" is an integral part of Putnam County's planning and transportation policy and allows for the design approach that requires streets to be planned, designed, operated, and maintained to enable safe, convenient, and comfortable travel; and

WHEREAS, Putnam County recognizes "Complete Streets is a critical plan for our future and also the need to encourage our local municipalities to develop a user-friendly plan for all ages and abilities regarding multi-modal transportation; and

WHEREAS, since 2018, Putnam County has focused on infrastructure enhancement and reducing fossil fuel consumption and considers Putnam ahead of the curve in New York State with an investment of \$8M in green energy; and

WHEREAS, Putnam continues to work with Ameresco, who has evaluated and assessed all county buildings through Article 9 - NYS Energy legislation that focuses on energy reduction and at the same time \$300,000 annual savings in reduced energy costs; and

WHEREAS, in July 2021, the Kern building solar panels were brought online with several other county facilities to follow; and

WHEREAS, this program's benefits are climate-smart and reduce our dependency on natural gas, diesel, heating oil, and propane; and

WHEREAS, Putnam County has established a plan for an enterprise fleet program and a three-year cycle of leasing fleet vehicles for departments to assure we have a fleet with the best fuel consumption (MPG) and considers the most fuel-efficient vehicles; and

WHEREAS, Putnam County has embarked on a regional feasibility and marketing study in 2021, the Southeast/Danbury Rail link study that considers the criticality of Complete Streets goals while mitigating traffic congestion as we improve the quality of life along with the Route 84/684 traffic choke point and further The study received unanimous support from the NYMTC, whose members include Putnam County, NYS DOT, NYC DOT, NYC Planning Department, Metropolitan Transit Authority (MTA) and Metro-North Railroad (MNR), and Nassau, Suffolk, Rockland, and Westchester County; now therefore be it

RESOLVED, that the Legislature hereby agrees that the goals for Putnam County's green infrastructure and enhanced energy-efficient facilities and transportation shall be to promote an integrated system that considers the needs of all residents and visitors using our roadways, bikeways, pedestrian walkways, public transportation riders', motorists and citizens of all ages and abilities, including children, the elderly and disabled; and be it further

RESOLVED, that the legislature further acknowledges that Complete Streets allows for safe travel to all residents and businesses and considers walking, cycling, driving automobiles, and those riding public transportation and the connections across all modes of transportation; and be it further

RESOLVED, that the Putnam County Legislature hereby approves of and acknowledges the importance of the Green Infrastructure & Complete Streets program which was developed through the coordinated efforts of the Putnam County Department of Highways & Facilities and the Putnam County Department of Planning, Development & Public Transportation, as well as several other relevant County departments and partners; and be it further

RESOLVED, that the County of Putnam, in order to reduce greenhouse gas emissions and adapt to a changing climate, *adopts the New York State Climate Smart Communities pledge, which comprises the following ten elements:*

- 1) Build a climate-smart community.

The proposed structure will consist of a 28-foot span 3-sided pre-cast concrete rigid frame which will be aligned with the stream. The bridge roadway section will consist of two 10-foot travel lanes and two 5-foot shoulders, resulting in a rail-to-rail width of 30 feet. The existing abutments and wingwalls will be completely or partially removed to accommodate the new substructure. New galvanized steel bridge three-rail with brush curb and box beam approach rail will be installed along the reconstructed area. This alternative will also improve the intersection layout of Sprout Brook Road and Winston Lane located adjacent to the structure. Traffic will be detoured around the site for the duration of constructions; and

WHEREAS, the proposed action is subject to review under the State Environmental Quality Review Act and the Regulations promulgated thereunder ("SEQRA 6 NYCRR Part 617"); and

WHEREAS, other potential involved or interested agencies have been identified in regards to the proposed action; and

WHEREAS, a short Environmental Assessment form (EAF) has been prepared for the proposed project along with supporting documentation; and

WHEREAS, the Putnam County Legislature, after a review of Part 617, finds that the proposed action is an Unlisted action; now therefore be it

RESOLVED, that the Putnam County Legislature hereby declares its intent to act as the Lead Agency under the procedures and requirements of SEQRA and will conduct a coordinated SEQRA environmental review for the proposed action.

WHEREAS, the County of Putnam ("County") is proposing to perform preliminary engineering, detailed design, right of way incidentals, right of way acquisition and construction support services of Sprout Brook Road (CR 15) over Canopus Creek, Town of Philipstown, County of Putnam, State of New York (P.I.N. 8762.13) (the "Project"); and

WHEREAS, the purpose of the Project is to replace the existing structure to redress poor condition of deck, superstructure (yellow flag), and substructure, and to address safety concerns. Also to provide wider bridge roadway to provide shoulders for pedestrians and bicycles and improve the right-turn radius from Winston Lane onto Sprout Brook Road; and

WHEREAS, the Project is a Locally Administered Federal Aid Transportation Project administered by the County; and

WHEREAS, the Project is being progressed by the County Department of Highways and Facilities, with oversight by the New York State Department of Transportation ("NYSDOT") and in close coordination with the Federal Highway Administration ("FHWA"), in accordance with Federal and State laws, regulations, rules and policies; and

WHEREAS, NYSDOT has determined that in order to progress the Project through the project design phase and right-of-way acquisition phase, it will be necessary for the County to conduct a public hearing on notice to the general public and affected landowners as provided for in the New York Eminent Domain Procedure Law; and

WHEREAS, the public hearing must be conducted at a convenient location for the purpose of affording the general public and affected landowners an opportunity to express any objections they may have to the proposed location of the Project; and

WHEREAS, at the public hearing, the County must outline the purpose, proposed location or alternate locations of the Project and provide any other information that the County considers pertinent, including maps and property descriptions of the property interests that may be acquired in order to accomplish the Project; and

WHEREAS, persons who attend or participate in the public hearing must be given a reasonable opportunity to present oral or written statements and submit other documents concerning the Project; and

RESOLVED, that at least ten (10) but not more than thirty (30) days prior to such public hearing, the Commissioner shall cause to be posted on the County Department of Highways and Facilities website, a notice of such public hearing; and be it further

Legislator Jonke stated that recently it came to his attention that two (2) residents of the Town of Southeast had lodged a complaint regarding flags installed at the train station in the Village of Brewster. Legislator Castellano stated that he was proud to second this resolution and the great work Legislator Jonke did to move this forward. He stated that the Village of Brewster is in his Legislative District and the train station is a beautiful building which is one (1) of the few original train stations on this train line. He stated that the gentleman who is the Korean War Veteran is an incredible patriotic person who shows up every morning to greet the commuters. He explained that this gentleman should get credit for decorating the train station and he is proud to have this gentleman as his neighbor.

Legislator Albano stated that he just became aware of this, and it was hard to believe. He stated that he is proud to be an American and was proud of the flags we have in Putnam County.

Legislator Nacerino stated she is very proud to support this. She stated that she is proud to be an American, to live in Putnam County and to display the flag of the United States of America. She thanked Legislator Jonke for bringing this forward.

Legislator Sayegh stated that the U.S. Flag is a symbol of freedom for all of us. It represents those who have fought and died to protect our freedom and makes it possible

to live in a free country to protest, to disagree and guarantees our freedom of speech. She stated that it also protects the people that complain. She stated that if we lose sight of what our country was founded on, we lose our freedom. She stated that the disrespect of removing them at our train station is nothing new. Our flag has been spat upon, burned, trampled and yet she rises time and time again. She stated that she will not stand by personally while our symbol of freedom, sacrifice and hope is torn down from the Brewster train station because of one (1) or two (2) complaints of someone offended. She stated that this deeply offends her and all who stand behind the freedoms, liberty, hope and sacrifice that our flag represents. She stated that we are one (1) generation away from losing our freedom which the flag represents. She stated that we need to stand strong in our resolve to always protect our flag. She thanked Legislator Jonke for bringing this forward.

Legislator Jonke recognized Village of Brewster Mayor, James Schoenig. He stated that Mayor Schoenig was the one (1) who brought this to his attention.

Legislator Sullivan thanked both Legislator Jonke for bringing this forward and Mayor Schoenig for bringing this to his attention. He explained that he is proud of the many flags displayed in Putnam County and it was great to show our patriotism. He echoed what all his fellow colleagues had already said.

Legislator Gouldman thanked Legislator Jonke and Mayor Schoenig. He stated that the American Flag is a symbol of freedom and democracy for the whole world, not just the United States. He stated that for someone to say that Putnam County has a large display of American Flags is something to be proud of. He stated that he is glad to live in a County that displays the American Flag.

Chairwoman Addonizio thanked Legislator Jonke for bringing this forward this evening. She questioned what was next, someone telling us that we don't have the right to fly the American Flag on our property because we will offend our neighbors? She thought that we lived in America, the land of the free because of the brave men and women who fought for our freedom. She stated that the American Flag has proved justice for over 225 years. The freedom to display the American Flag Act of 2005 found in Title IV of the US Code prohibits any community association, such as a condo association, from restricting or preventing any homeowner from displaying the flag of the United States on their personal property. She stated that her flag represents liberty, justice, freedom and love of country.

Legislator Jonke moved the following resolution which he read into the record; seconded by Legislators Albano and Castellano.

RESOLUTION #159

APPROVAL / SUPPORT FOR RESTORING THE DISPLAY OF AMERICAN FLAGS AT THE BREWSTER TRAIN STATION

WHEREAS, the Flag of the United States of America is a symbol of freedom and liberty to which Americans pledge their allegiance; standing at attention and facing the flag with our right hand over the heart, we recite: "I pledge allegiance to the flag of the United States of America, and to the republic for which it stands, one nation under God, indivisible, with liberty and justice for all"; and WHEREAS, the American Flag's 13 alternating red and white stripes represent the 13 original colonies, and its 50 white stars on a blue field represent all 50 states; and

WHEREAS, the colors on the flag and what they represent are: Red for valor and bravery; White for purity and innocence; and Blue for vigilance, perseverance, and justice; and

WHEREAS, Public Law 94-344, known as the Federal Flag Code, makes clear that the flag is a living symbol of a living country; and

WHEREAS, a patriotic display of American Flags at the Brewster train station in Putnam County, which flags were donated by a local veteran of the United States Armed Forces, was recently removed due to a complaint made to the Metropolitan Transportation Authority (MTA); and

WHEREAS, the MTA demonstrates its enthusiasm for the display of the American Flag by including its depiction on MTA locomotives and train cars; and

WHEREAS, the respectful and patriotic display of American Flags at the Brewster train station, or any other respectful and patriotic public display of American Flags, is entirely appropriate and welcomed by all good citizens of Putnam County; now, therefore be it

RESOLVED, that the Putnam County Legislature respectfully calls upon the MTA to restore the display of American Flags at the Brewster train station; and be it further

RESOLVED, that copies of this resolution shall be sent to the management of the MTA and Putnam County's representative on the MTA Board.

Item #8 – Recognition of Public on Agenda Items

Barbara Scuccimara of the Town of Philipstown commented on Item #6d - "Green Infrastructure" and "Complete Streets" Climate Smart Initiative. She stated that this initiative is about clean water, which is high on everyone's priorities. She explained that the Town of Philipstown has a very steep Main Street, and everything flows down towards the Hudson River. She stated that she would do anything to protect that river and she believed that this was a great initiative. She stated that there are many things that can be done besides just putting solar panels on our building. She stated that years ago she had a discussion with the County Executive to see what Department Heads had already begun working on Climate Smart Initiatives without realizing it such as, energy initiatives, using less styrofoam and planting rain gardens. She explained how even small changes will eventually make a big difference. Ms. Scuccimara proceeded to comment on Item #6m - Household Hazardous Waste Day. She claimed that it is worth the extra money to run this event so Hazardous substances do not leach into water bodies. She believes that this is an important educational opportunity like medication take back day which she brought into the Town of Philipstown.

Putnam County Transportation Manager Vincent Tamagna thanked the Legislature for the budgetary amendment for the Planning Department. He explained that he was proud to say the Planning Department Transit Facility renovation project was finished on schedule, high quality, and within budget. He stated that they are starting phase two, the interior and the architecture of the actual building. He commented on complete streets and the controversy surrounding it. He stated that they have been working on Climate Smart and Complete Streets for a long time, "doing the job that the County Executive wants us to do." He stated that they have created a draft of a Complete Streets plan for the Village of Brewster and are currently working on the Village of Cold Spring. He provided an overview of some of the recommendations in the draft plan for the Village of Brewster. He invited the Legislators to come to the Planning Department to review the draft. He pointed out that Legislator Scuccimarra started the initiative in 2017. He touched upon Item #7 - Restoring the Display of American Flags at the Brewster Train Station and thanked the Legislature and Putnam County for being as patriotic as they are.

Bureau of Emergency Services Commissioner Kenny Clair addressed Item #6a – Budgetary Transfer (21T128)/ EMS/ Two (2) New Emergency Service Dispatcher Positions. He thanked the Legislature, Protective Services Committee, and the County Executive for their support in approving the two (2) new dispatcher positions as we move forward with the consolidation. He stated that it will give them the opportunity to have three (3) dispatchers on the midnight shift. He thanked the Legislature, specifically Legislator Jonke for bringing up agenda Item #7 – Restoring the Display of American Flags at the Brewster Train Station.

Kevin McConville of the Town of Philipstown thanked the Legislature for approving Item #6a - Budgetary Transfer (21T128)/ EMS/ Two (2) New Emergency Service Dispatcher Positions. He believed that it would be a benefit to visitors, residents, and first responders in Putnam County.

Serena Tamagna of the Town of Philipstown addressed agenda Items #6g and #6h regarding the Sprout Brook Road Bridge Replacement. She stated as a former resident of Continental Village, she thanked the Legislature for rebuilding infrastructure and making sure Emergency Services are well equipped.

Mayor Schoenig of the Village Brewster read the email he had received regarding the disapproval for the flags at the Brewster train station. He expressed his appreciation for the Legislature's efforts in approving the resolution requesting that the MTA restore the display of the flags.

Item #9 - Recognition of Legislators

Legislator Albano expressed his pride for the progress that the County has made regarding Climate Smart and Street Smart initiatives over the years. He stated that there has been a tremendous amount of work done, such as a side walk project, connecting bike trails and investing in automatic lights. He explained how these efficiencies are a priority and are a benefit to taxpayers and the environment.

Legislator Sayegh recognized the passing of Dr. Raymond Phillips, a distinguished member of the Board of Health. He passed away July 14th at 90 years old. She provided an overview of his accomplishments and offered her condolences to his family.

Legislator Sullivan discussed how COVID-19 numbers are rising due to the Delta variant but noted that hospitalization numbers are extremely low. He stated that the long-term consequences of COVID-19 are still not fully understood, so everyone should take COVID-19 seriously and protect themselves and their community by getting vaccinated. Legislator Jonke thanked Mayor Schoenig for being here tonight and making him aware of the situation at the Brewster train station, his colleagues for their support on the resolution, and Legislative Counsel for drafting this wonderful resolution.

Chairwoman Addonizio stated that August is designated as Children's Eye Health and Safety Month. She stressed the importance of having your child's eyes examined during well child visits. She stated that the eye doctor can detect near sightedness, far sightedness and astigmatism as well as eye diseases. She stated that eye injuries are the leading cause of vision loss in children. There are 42,000 sports related injuries every year in America and children suffer most of these injuries. She stated that there are many eye conditions that can affect a child's vision and it is important to be aware of any visible changes; some obvious and some very subtle. She explained how recently her two (2) year old granddaughter was diagnosed with a rare eye cancer called retinoblastoma. She explained how her daughter noticed a haze over one (1) of her child's eyes and immediately called a pediatric ophthalmologist. She was diagnosed and received treatment at Sloan Kettering within days. She explained that she is speaking about this tonight to bring awareness to the many different eye diseases that affect children. She stated that by acting quickly can save vision and your child's life.

There being no further business, at 8:00 P.M., Chairwoman Addonizio made a motion to adjourn; seconded by Legislators Jonke and Castellano. All in favor.
