YEAR END MEETING OF THE PUTNAM COUNTY LEGISLATURE HELD IN ROOM 318 PUTNAM COUNTY OFFICE BUILDING CARMEL, NEW YORK 10512

Wednesday December 22, 2021

(Immediately following Audit & Admin. Mtg. starting @ 6:30 P.M.)

The meeting was called to order at 7:44 P.M. by Chairwoman Addonizio who requested Legislator Montgomery lead in the Pledge of Allegiance and Legislator Sullivan lead in the Legislative Prayer. Upon roll call, Legislators Montgomery, Gouldman, Nacerino, Albano, Jonke, Castellano, Sullivan and Chairwoman Addonizio were present. Legislator Sayegh was absent. Also present was Legislative Counsel Firriolo.

Item #4 - Correspondence

a) County Auditor

There was no activity during the reporting period.

Item #5 - Pre-filed resolutions:

HEALTH, SOCIAL, EDUCATIONAL & ENVIRONMENTAL COMMITTEE (Chairwoman Sayegh, Legislators Addonizio & Nacerino)

Item #5a – Approval/ Opposing Government Mandated COVID-19 Vaccination was next. On behalf of the members of the Health, Social, Educational & Environmental Committee, Legislators Sayegh and Nacerino, Chairwoman Addonizio moved the following:

Chairwoman Addonizio stated that she received over 300 petition signatures and approximately 100 emails to the Legislative Office in support of this resolution. She stated that people are concerned and scared for their children, and they want to make a difference. She stated that she is not anti-vaccination; she is anti-mandate. She stated that she is not here to abolish childhood vaccinations that are required to enter school. She explained that the COVID-19 vaccine mandate does not take into consideration any religious or health exemptions, even though there has always been the opportunity for a child to be exempt from immunizations due to a valid medical exemption according to the NYS Department of Health website. She stated that Assembly Bill #A8378 authorizes the Commissioner of Health to develop and supervise the execution of a program of immunization against COVID-19 for purposes of State Aid to schools. She stated that this is one (1) of the first Bills to probably be voted on when they resume on January 6th. She stated that the Bill is in Committee and will most likely pass the Assembly and then go to the Senate for an immediate vote. She stated that the sponsor of this Bill is Jeffrey Dinowitz, and the cosponsor is Philip Steck. She noted that these two Assemblymen were responsible for voting against religious exemptions for children in 2019. She explained that this is not an anti-vaccination resolution, in fact, it supports Putnam County's campaign to assist people who want to get vaccinated. She stated that the resolution also does not make any judgment about the science of vaccines, instead it is a statement of public policy which is the proper rule of the Legislature. She stated that

vaccine mandates are not only bad public policy, but they are also not supported by sound science or sound medical ethics. She stated that she was proud to bring forward this resolution. Chairwoman Addonizio read the resolution.

Legislator Sullivan explained that he believed in free will and that it was a person's choice to wear a mask or get a vaccine. He stated that it was not that we did not want them to get a vaccine or wear a mask, but it was their choice to do what they want and not the government's role to tell them what to do. He stated that he was a firm believer in freedom and the ability to make your own decisions as an adult for yourself and family. He stated that he was in favor of this resolution.

Legislator Montgomery explained last she counted there were approximately 50 emails which she read. She questioned whether Chairwoman Addonizio shared this resolution with her constituents. She questioned if the people who wrote to the Legislature were aware that what you are opposing in your resolution pertains to vaccines mandated for anyone, adults included, working anywhere in any setting such as, nursing homes, group homes, hospitals and health care centers. She stated that what you are saying in this resolution is that you do not think it is necessary for OSHA to mandate that nurses and doctors be vaccinated who are taking care of my elderly friends, parents and sick children. She stated that the first sentence of the resolution appears to be opposing the emergency temporary standard (ETS). She explained why she believed that paragraphs three (3) and four (4) were irrelevant. She stated that she asked at the last Health Committee meeting that we separate children out of this resolution because that seems to be the main concern. She stated that with this resolution, the County has done very little to protect their employees from transmission. She explained that there was an outbreak in the Sheriff's Department. She believed there were many problems with the resolution which she elaborated on. She stated that Putnam County has the most COVID cases per 100,000 residents in the Hudson Valley region.

Legislator Jonke stated that almost two (2) years ago we were told that it would take two (2) weeks to flatten the curve. He stated that the Country was shut down, government asked us to get vaccines and yet the rates are still increasing. He believed that government has gotten nothing right. He stated that he does not need medical advice to tell me that this vaccine mandate is wrong. He stated that we used to be the "land of the free" and we are less free than we were two (2) years ago. He stated that he was not antivaccine. He stated that both he and his daughter were vaccinated. He stated that this legislation would provide that a 14-year-old child in school could be vaccinated without their parents' consent. He stated that the idea that government knows better for a child than the parent was completely inappropriate. He believed if we did not push back, we would be steamrolled. He believed that we have been steamrolled for two (2) years now.

Legislator Albano stated that he totally supports this resolution and concurs with Legislator Jonke. He stated that they are telling people to do something without any clear evidence. He stated that we have vaccines, with close to 70% vaccinated and we are still dealing with this. He stated that he did not want anyone telling him what to do, especially when it applied to his children.

Legislator Nacerino stated that she received a groundswell of support for this resolution from her constituents. She stated that the essence of this resolution clearly states that we believe medical treatment and preventive measures are an individual choice and government has no role in mandating COVID vaccinations. She stated that we are not

saying we are anti-vax or attempting to encourage or persuade anyone against the COVID-19 vaccine. She stated that she and her family are vaccinated and have received their booster shots. She stated that this is about personal choice and personal liberties to make decisions regarding what is injected in our own bodies and that of our children without governmental interference.

Legislator Castellano concurred. He stated that he was amazed at where we have been in the last two (2) years. He stated that he could not imagine having children in the school districts right now with all these concerns going on in the world. He believed that it was the parents' decision to make. He explained that he and his wife are vaccinated, along with his adult children who decided to be vaccinated as well. He stated that he did not know what happened to HIPAA regulations regarding not knowing a persons' medical condition. He believed that it was important to be vaccinated, however, he explained that if a person decides not to be vaccinated, because of whatever issue they might have, he believed that he should not be made aware of the reason and that person did not need to be vaccinated. He stated that he is fully in support of this resolution.

Legislator Gouldman stated that the last two (2) years have been very humbling. He stated that he is not a doctor or have been trained in any type of healthcare electives. He stated that our Federal and State government have acted like clowns in the last few years regarding the COVID-19 issue. He stated that he has been following the science and, in his opinion, it was sending mixed messages. He stated that he is not anti-vax. He stated that he has been vaccinated and will be receiving the booster very soon. He believed that the decision to get the vaccine was a personal one between you, your family and your healthcare provider. He did not believe it should be mandated by government. He stated that he supports this resolution.

Legislator Montgomery clarified that the ETS had nothing to do with children. She stated that she hated that we could not mandate vaccinations for our correction officers or people providing this vaccine service in our Health Department.

RESOLUTION #295

APPROVAL / OPPOSING GOVERNMENT MANDATED COVID-19 VACCINATION

WHEREAS, on September 9, 2021, the federal government announced plans to direct the U.S. Department of Labor's Occupational Safety and Health Administration ("OSHA") to develop an emergency temporary standard ("ETS") directed at private-sector businesses with one hundred (100) or more employees to require their employees to either be vaccinated against the COVID-19 virus or require any workers who remain unvaccinated to produce a negative test result on at least a weekly basis before coming to work; and

WHEREAS, it is anticipated that the OSHA ETS will impact over 80 million workers in private-sector businesses with one hundred (100) or more employees; and

WHEREAS, in light of the stay recently issued by the 5th Circuit Court of Appeals finding that legal challenges to the ETS are "likely to succeed on the merits," OSHA has suspended its activities related to the implementation and enforcement of the ETS pending the outcome of the constitutional challenges; and

WHEREAS, on November 29, 2021, a preliminary injunction was issued by the United States District Court for the Eastern District of Missouri against enforcement of the vaccine mandate against any and all Medicare- and Medicaid-certified providers and

suppliers within the States of Alaska, Arkansas, Iowa, Kansas, Missouri, Nebraska, New Hampshire, North Dakota, South Dakota, and Wyoming; and

WHEREAS, private-sector employers have been overwhelmed by the contingencies, restrictions, and requirements placed upon them due to COVID-19, especially over the last two years; and

WHEREAS, the Putnam County Legislature believes that medical treatment and preventative measures are an individual choice and that the government has no role to play in mandating COVID-19 vaccinations; and

WHEREAS, the County of Putnam implemented a successful campaign and vaccination program to ensure that residents of the County who want to be vaccinated against the COVID-19 virus have that option and have vaccine administered to them; and

WHEREAS, every citizen who wants a COVID-19 vaccine possesses the right to obtain one, but no COVID-19 vaccine should be mandated by law; and

WHEREAS, people have the right to refuse for themselves, and parents for their children, COVID-19 vaccination based on religious or medical reasons, and every medical intervention requires informed consent and the right of refusal, including the COVID-19 vaccine; now, therefore be it

RESOLVED, that the Putnam County Legislature expresses its opposition to COVID-19 vaccine mandates by any local, state, or federal government that affect citizens' rights to make their own health care choices; and be it further

RESOLVED, that the Putnam County Legislature expresses its opposition to COVID-19 vaccine mandates by any local, state, or federal government that affect parents' rights to make health care decisions in the best interests of their children; and be it further

RESOLVED, that the Putnam County Legislature continues to encourage all citizens who make the individual choice to get vaccinated against the COVID-19 virus to avail themselves of the many opportunities to receive the vaccine; and be it further

RESOLVED, that the Putnam County Legislature continues to encourage all citizens who make the individual choice not to get vaccinated against the COVID-19 virus to follow the most recently updated Center for Disease Control and Prevention (CDC) guidelines; and be it further

RESOLVED, that the Clerk of the Putnam County Legislature shall send certified copies of this Resolution to the President of the United States of America, Joseph R. Biden, New York State Governor Kathy Hochul, and to each New York State Senator and Assemblyperson who represents the County of Putnam; and be it further

RESOLVED, that this Resolution shall take effect immediately.

Item #5d – Authorization for Intermunicipal / Agreement with Westchester County to Effectuate a Mutual Aid and Rapid Response Plan for the Police Departments of Participating Municipalities and to Delegate to the Sheriff the Powers Granted to the Chief Executive Officer to Request and Grant Police Assistance was next. On behalf of the Rules, Enactments & Intergovernmental Relations Committee, Legislators Albano and Castellano, Legislator Sullivan moved the following:

RESOLUTION #298

AUTHORIZATION FOR INTERMUNICIPAL AGREEMENT WITH WESTCHESTER COUNTY TO EFFECTUATE A MUTUAL AID AND RAPID RESPONSE PLAN FOR THE POLICE DEPARTMENTS OF PARTICIPATING MUNICIPALITIES AND TO DELEGATE TO THE SHERIFF THE POWERS GRANTED TO THE CHIEF EXECUTIVE OFFICER TO REQUEST AND GRANT POLICE ASSISTANCE

WHEREAS, the police departments of Westchester County, New York have created and entered into a Mutual Aid and Rapid Response Plan (the "Plan") to formalize operational procedures for Law enforcement assistance to participating agencies; and

WHEREAS, each member police agency agrees to make available its police personnel and equipment to the others upon the occurrence of a condition which is beyond the scope of its police resources; and

WHEREAS, the County of Putnam desires to enter into this existing agreement with neighboring municipalities in and outside of Westchester, invitation to entry having been extended by the County of Westchester; and

WHEREAS, entry into such intermunicipal agreement is permitted under Article 5-G of the General Municipal Law; and

WHEREAS, due to prevailing world, national, and local security situations, the ever-increasing flow of intelligence, and actual threats directed against once benign sites and facilities, the parties desire that the Plan be flexible and subject to review and revision as necessary in a timely manner; and

WHEREAS, the Plan is governed by, and liabilities and costs are apportioned pursuant to, the provisions of New York State General Municipal Law Section 209-m, which provides, inter alia, that absent agreement to the contrary, the municipality receiving police aid shall reimburse the municipality providing such aid for any money paid by it for police salaries and other expenses incurred by it including damage to, or loss of, equipment and supplies; and

WHEREAS, the Plan is to be revised as necessary and revisions to the Plan will be approved and implemented by the Westchester County Chiefs of Police Association, and

such revisions may include, but are not limited to, updates in protocols and additions of new municipalities and their police departments located within or outside of the physical boundaries of Westchester County to participate in the Plan; now therefore be it

RESOLVED, that the County of Putnam be and hereby is authorized to enter into an inter-municipal agreement ("IMA") with certain municipal corporations as defined in Article 5-G of the New York State General Municipal Law, located both within and outside of the County of Westchester (collectively the "Participating Municipalities"), in order to effectuate a Mutual Aid and Rapid Response Plan for the police departments of the Participating Municipalities (the "Plan") to carry out the purposes described in Section 209-m of the New York State General Municipal Law; and be it further

RESOLVED, that such IMA and the Plan shall be substantially similar in form and content to the draft items accompanying this Resolution; and be it further

RESOLVED, the term of the IMA will conform with the existing term agreed upon by the municipalities, which is five (5) years commencing on July 31, 2020, and continuing through July 30, 2025; and be it further

RESOLVED, that the County Executive is authorized to execute said IMA on behalf of the County of Putnam; and be it further

RESOLVED, that this Resolution shall take effect immediately.

Item #5g – Approval/ Lease Agreement/ Tilly Foster Farm, Building #7/ Jar Worthy, Inc. was next. On behalf of the members of the Physical Services Committee, Legislators Castellano and Gouldman, Legislator Albano moved the following:

Legislator Albano made a motion to accept the additional revised lease; seconded by Legislators Sullivan and Nacerino. All in favor.

Legislator Albano stated that the revised lease is for two (2) years, and it included an insurance clause. He stated that he visited the facility this weekend. He stated that the facility is beautiful. He stated that he would welcome something like this for no rent in a sense because it complements the farm, and it is not a big enterprise. He explained that the building was vacant and in need of a lot of repairs. He stated that heat and electric was kept on because the basement houses an area that provides water for the farm. He believed this lease provided a good opportunity to utilize the facility and bring people to the farm.

Legislative Counsel Firriolo clarified that the additional Legislator Albano moved forward not only contained the revised lease, but it also contained a revised resolution. He explained that the resolution moved out of Committee was before the Watershed Agricultural Council (WAC) gave its approval. He stated that the Law Department provided this revised resolution to account for the fact that WAC has approved this.

Legislator Montgomery questioned if the change in the lease provides that the tenant carries insurance. She questioned the actual change in the lease.

Legislator Albano stated that they must maintain liability insurance and list the County as additional insured.

Legislative Counsel Firriolo stated that Article VIII of the lease contains a new second paragraph which pertains to what Legislator Albano explained.

Legislator Montgomery questioned if manufacturing a product required additional insurance.

Legislator Albano stated that he did not believe there was a requirement. He stated that when you say "manufacturing" he stated that basically what Jar Worthy has is a little crockpot that uses water to heat anything she would make pertaining to candles.

Legislator Montgomery stated that if you are making something and selling it you are manufacturing something no matter what size.

Legislator Jonke stated that during the Committee meeting he had an objection to the process. He stated that it is keeping with the vision of the Administration, and he understands that the person in the facility was wonderful, however, he believed they were put in a bad position with the fact that they were given keys to this space and permission to improve the space without a lease. He explained that he has a background in commercial property ownership, and he would never allow anyone into a space without a lease. He stated that the lease then went from four (4) years to two (2) years with no 3% escalation. He believed there was transparency lacking and his fear was that somewhere

down the road one (1) of his constituents may come to him and ask why they were not given an opportunity to have their business at this location. He stated that for those reasons he would be voting no. He explained that his vote was not a reflection on the business owners or the business itself. He stated that it was a reflection on the process.

Legislator Castellano explained that he visited the facility this past weekend. He explained that he had been in the building before and was aware of what it was being used for regarding the intake for water in the basement, and he believed the internet went through there as well. He stated that the building is vitally important. He explained that the improvements they made on the first floor kept with the character of the farm. He explained that they are making candles, but they are not a huge manufacturer of candles. He stated that he liked that it was changed to a two (2) year lease, and he wished the tenants the best. He believed it was an improvement to Tilly Foster Farm and he encouraged people to visit the store. He stated that he would support this lease.

Legislator Albano stated that the lease states that the first floor is approximately 1600 square feet. He believed that it was closer to 1300 square feet that was being utilized. He stated that one (1) of the areas is an unheated front porch, like a three (3) season room, that could be considered as an entrance.

Legislator Sullivan believed that it was important to support local businesses and given that we are doing everything we can to keep businesses alive during COVID, we are supporting this business. He believed that they were a nice fit for the type of facility Tilly Foster Farm is becoming and he was in favor of this lease.

Legislator Montgomery stated that she appreciated what Legislator Jonke said. She explained that she asks questions and a lot of the time it has nothing to do with the person, but it has everything to do with the process and her job as a County Legislator was to protect the County. She stated that these are probably wonderful people. She stated that she supports women in business, and she believed there were a lot of businesswomen in her district that would love to fix up a place for \$800.00 a month rent. She stated that we are giving the keys to the County away and giving keys to Advanced Life Support (ALS) away before we have a signed contract. She questioned if the lease was going to start when they entered in October. She stated that she understands it is an internet business. She questioned if there would be shipping out of there which does not seem to be in keeping with the farm. She believed the public had the right to know the market value of the facility, and the relationship between the General Manager of Tilly Foster Farm and the tenant. She believed it was not ethical to give space away to friends and family which no one has been able to address.

Legislator Sullivan stated that he wanted to talk about the so-called nepotism. He stated that we all know that Putnam County is small. He stated that people know one another and often the best people for the job happen to know one another. He stated that this is true on both sides of the County and in his opinion, it is part of what makes Putnam County great. He believed it was counterproductive to use this as a weapon and quite frankly it is taking a cheap shot because the argument is weak. He stated that we are a small County, and everyone knows each other. He believed to say it was nepotism was not fair to the people involved.

Legislator Albano explained that we were not in the business to rent space and could probably leave it empty because there are disadvantages in renting. He stated that we

were not anxious to rent out this building and it was not advertised. He stated that we have a building across the street that will probably be torn down. He stated that this business is conducive to the farm and works very well.

Legislator Albano stated that he would like to call the question.

Legislative Counsel Firriolo stated that procedurally, the additional lease and resolution were accepted as additional, however, in order to vote on that, you would need a motion to substitute the revised lease and resolution on the floor and then it could be voted on.

Legislator Albano made a motion to substitute the revised lease and resolution; seconded by Legislator Castellano. All in favor.

Legislator Montgomery questioned who and how the profits would be tracked and how we would know what they were using from the farm.

Legislator Albano stated that the candles are their business, however, in addition to that they will assist the County in selling some things the County will offer.

Legislator Montgomery questioned where that agreement was.

Legislator Albano stated that it was in the lease.

WHEREAS, the County will have the opportunity, through Jar Worthy, Inc.'s lease of the Surplus Space, to make its products accessible to the general public and to realize the financial benefits of its agricultural production; and

WHEREAS, Tilly Foster Farm, Building #7 is currently located in the Municipal Acceptable Development Area of the conservation easement with the Watershed Agricultural Council ("WAC"), and as such would require a change of use; and

WHEREAS, the County requested such change of use for Tilly Foster Farm, Building #7 through the Watershed Agricultural Council's Committee and has received said approval on December 10, 2021; and

WHEREAS, pursuant to Section 31-22 of the Putnam County Code, the County Executive has requested that the Putnam County Legislature approve the lease agreement which is attached hereto as Schedule "B", which has also been approved by WAC; now therefore be it

RESOLVED, that the Surplus Space located at Tilly Foster Farm, Building #7 is not needed for County use; and be it further

RESOLVED, that the Putnam County Legislature approves the Lease Agreement between the County of Putnam and Jar Worthy, Inc. for the Surplus Space, in the form attached hereto and made a part hereof as Schedule "B", and that the Putnam County Executive is authorized to execute said Lease Agreement; and be it further
