## REGULAR MEETING OF THE

## PUTNAM COUNTY LEGISLATURE HELD VIA AUDIO WEBINAR PURSUANT TO TEMPORARY EMERGENCY ORDERS

Tuesday May 4, 2021 7:00 P.M.

The meeting was called to order at 7:02 P.M. by Chairwoman Addonizio who led in the Pledge of Allegiance and Legislative Prayer. Upon roll call, Legislators Montgomery, Gouldman, Nacerino, Jonke, Castellano, Sayegh, Sullivan and Chairwoman Addonizio were present. Legislator Albano was absent. Also present was Legislative Counsel Firriolo.

## **PROCLAMATIONS**

Chairwoman Addonizio stated that the following proclamations are for informational purposes only and will be mailed to the relevant parties.

## **ALCOHOL AWARENESS MONTH - MAY 2021**

WHEREAS, alcohol is the most commonly used addictive substance in the United States. One in every 12 adults (17.6 million people) suffer from alcohol abuse or dependence; and

WHEREAS, underage drinking presents an enormous public health issue and alcohol is the drug of choice among children and adolescents. Annually, approximately 5,000 youth under the age of 21 die from motor vehicle crashes, other unintentional injuries, homicides, and suicides that involve underage drinking; 100,000 persons die each year from alcohol-related causes: drinking and driving crashes, other accidents, falls, fires, alcohol-related homicides and suicides; and

WHEREAS, tragic health, social, and economic problems result from the use of alcohol by youth. Underage drinking is a causal factor in a host of serious problems, including traumatic injury, violent and property crime, high risk sex, fetal alcohol syndrome, alcohol poisoning, and need for treatment for alcohol abuse and dependence; and

WHERES, the 2018 Prevention Needs Assessment Survey reports that 42.9% of Putnam County youth grades 8-12 have used alcohol in their lifetime; and

WHEREAS, young people who begin drinking before the age of 15 are four times more likely to develop alcohol dependence and are two and half times more likely to become abusers of alcohol than those who begin drinking at age 21; and

WHEREAS, over 7 million children live in a household where at least one parent is dependent on or has abused alcohol; and

WHEREAS, alcohol-related problems cost America \$224 billion in lost productivity, absenteeism, healthcare costs, crime, and family-related problems; and

WHEREAS, the typical American will see 100,000 beer commercials before he or she turns 18; now therefore be it

RESOLVED, that the Putnam County Executive and the Putnam County Legislature do hereby proclaim May 2021 as Alcohol Awareness Month and along with the Putnam Communities That Care Coalition and all substance abuse prevention and treatment providers in Putnam County encourage all residents to increase their awareness of alcohol use disorders, the dangers of alcohol abuse, the success of prevention and treatment programs, especially for our youth, and to support and

encourage referrals for treatment of individuals when an alcohol use disorder is suspected or present.

## **APRAXIA AWARENESS DAY - MAY 14, 2021**

WHEREAS, May 14th marks Childhood Apraxia of Speech Day during which awareness will be raised throughout Putnam County, New York about Childhood Apraxia of Speech (CAS), an extremely challenging speech disorder that affects 1-in-1,000 children; and

WHEREAS, CAS causes children to have significant difficulty learning to speak and is among the most severe speech deficits in children; and

WHEREAS, the act of learning to speak comes effortlessly to most children. Those with apraxia require early, appropriate, and intensive speech therapy often for many years to learn to speak; and

WHEREAS, without appropriate speech therapy intervention, children with Apraxia will have diminished communication skills, but are also paced at high risk for secondary impacts in reading, writing, spelling, and other school-related skills; and

WHEREAS, that such primary and secondary impacts dimmish future independence and employment opportunities and challenge the ability to become productive, contributing citizens if not resolved or improved; and

WHEREAS, our highest respect goes to these children, as well as their families, for their effort, determination, and resilience in the face of such obstacles; now therefore be it

RESOLVED, that the Putnam County Executive and the Putnam County Legislature do hereby proclaim May 14, 2021 as Apraxia Awareness Day and encourage citizens of Putnam County to work within their communities to increase awareness and understanding if Childhood Apraxia of Speech.

## NATIONAL CORRECTIONAL OFFICERS WEEK - MAY 3-7, 2021

WHEREAS, on May 5, 1984, President Ronald Reagan did proclaim that the first full week of May each year would be observed as National Correctional Officers Week, in recognition of the important role these officers play in our criminal justice system; and

WHEREAS, in the year 2021 Correctional Officers and other Correctional Employees continue to play that important role, but in an ever more stressful environment due to the current pandemic sweeping our nation and the world; and

WHEREAS, even as President Reagan observed in his 1984 Proclamation, the position of a Correctional Officer, once considered merely that of a "guard", has become increasingly more complex and demanding, involving simultaneously custodial, supervisory and counseling roles, and that complexity continues to grow; and

WHEREAS, the Putnam County Legislature wishes to acknowledge the difficult job we ask these officers and employees to perform, locked inside a facility for a large part of their day, where they must securely, safely and humanely keep those committed to the jail, respecting the rights and dignity of all the inmates, including those who have been found guilty and those only awaiting adjudication; and

WHEREAS, the important and difficult role these Correctional Officers and correctional employees fulfill is not always recognized or appreciated by the general public; now therefore be it

RESOLVED, that the Putnam County Legislature and the County Executive do hereby declare the week of May 3-7, 2021 as Correctional Officers Week in Putnam County and we acknowledge the conscientious, difficult and dedicated service our Correctional Officers and Correctional Employees perform for the People of Putnam County, and does further extend to those good public servants our gratitude for jobs well done.

## NATIONAL POLICE WEEK - MAY 9-15, 2021

WHEREAS, by Presidential Executive Order and Resolution of the Congress, May 15 of each year is recognized as Peace Officer's Memorial Day, honoring all law enforcement officers who have died in the line of duty; and

WHEREAS, the week in which Peace Officer Memorial Day falls is celebrated as National Police Week, recognizing the important role that law enforcement officers play in safeguarding the rights and freedoms of all citizens; and

WHEREAS, law enforcement officers perform an essential public service under difficult circumstances, especially today, in view of the COVID pandemic and the Nation's unrest; and

WHEREAS, the vast majority of law enforcement officers are selfless public servants who accept as part of their profession being exposed to great danger in order to protect the life and property others; and

WHEREAS, these dedicated officers deserve to be honored for their willingness to perform that essential public service on behalf of all our citizens; and

WHEREAS, the Putnam County Legislature wishes to acknowledge the difficult job we ask our Deputy Sheriffs and other police officers to perform, and to thank them for their willingness to do it; and

WHEREAS, the Putnam County Legislature is desirous of recognizing and honoring all those law enforcement officers who, over the years, have lost their lives in the line of duty; now therefore be it

RESOLVED, that the Putnam County Legislature and the County Executive acknowledge and honor the service of our Deputy Sheriffs, and all other police officers who have served, and who are serving in the County. We hereby declare May 15, 2021 to be Peace Officer Memorial Day in the County and does further declare the week of May 9 to 15, 2021 to be Police Week in Putnam County.

#### NATIONAL SAFE BOATING MONTH - MAY 2021

WHEREAS, recreational boating is a fun and enjoyable sport while being an excellent source of relaxation; however, boating can be a risky sport for the unprepared; and

WHEREAS, knowledge and skills are important in reducing human error and improving judgment when boating. If a person is aware of the risks, they are likely to take precautionary measures to protect themselves, their family, and their friends; and

WHEREAS, the United States Coast Guard Auxiliary, Putnam County Sheriff's Department, Carmel Police Department, has served the County providing boating education courses, making marine dealer visitations, conducting boating safety checks, and tending multi-mission patrols. Using their own boats and equipment, the Coast Guard Auxiliary has been able to reduce boating accidents and fatalities; and

WHEREAS, these vital services offered by the Coast Guard Auxiliary, Putnam County Sheriff's Department, Carmel Police Department, work in conjunction with local law enforcement, specifically the Carmel Police Department and Putnam County Sheriff's Department, to maintain safety on the water. As a result of the careful attention placed on boating, the waters of Putnam County are made safer through spreading messages of boating safety, not only during National Safe Boating Month, but throughout the entire year; now therefore be it

RESOLVED, that the Putman County Executive and the Putnam County Legislature do hereby support the goals of the North American Safe Boating Campaign and proclaim May 2021 as "National Safe Boating Month" in Putnam County and the start of the year-round effort to promote safe boating.

WHEREAS, Putnam County includes a growing number of older Americans who have built resilience and strength over their lives through successes and difficulties; an

She stated that we had a hard time getting License Plate Readers (LPRs) for the Sheriff's Department. She believed that security cameras at the County Office Buildings seemed a little obsessive.

Legislator Castellano stated that the additional funding was for \$35,000. The previous resolutions approved the funding, however, additional expenses have incurred since 2017 and 2020. He stated that the funds being approved are \$35,000 to cover the cost.

Legislator Nacerino believed that it was important, especially in this day and age, to have Access Control systems throughout our County facilities.

Legislator Jonke stated that he valued the safety of our employees and those individuals who visit our facilities. He stated that he would support this request.

Legislator Sullivan believed this was very important. He explained that the County Office Building has many departments that residents go to such as; the Finance Department where people pay their taxes and the County Clerk's office where people obtain information pertaining to public records and deeds. He stated that there are many

people coming in and out of the building and he believed that it was important to tighten security by installing cameras.

#### **RESOLUTION #74**

APPROVAL/ HIGHWAYS & FACILITIES/ USE OF CAPITAL FACILITY RESERVE/ ADDITIONAL FUNDING (CP-6 OF 2017 & 20CP01 OF 2020) (Access Control)

WHEREAS, by Resolution #144 of 2017 & Resolution #55 of 2020, the Putnam County Legislature approved the use of Capital Project Funds for an "Access Control" Project to provide uniform access control systems throughout County Facilities, for a combined total expenditure not to exceed \$157,537; and

WHEREAS, the County is seeking to Revise Resolution #55 of 2020, 20CP01 Access Control project, to include upgrading the security cameras at the County Office Building; and

WHEREAS, the Commissioner of Highways & Facilities has requested an additional amount of \$35,000 to cover this work, for which project scope is attached; and

WHEREAS, the Physical Services Committee has reviewed and approved this request; now therefore be it

RESOLVED, that the Putnam County Legislature approves and authorizes the expenditure of an additional \$35,000 for 20CP01 – Access Control from the Capital Facility Reserve fund budget line 55197000 53000 51509 as follows:

\$ 82,537 - Approved by Resolution #144 of 2017 (CP-6)

\$ 75,000 - Approved by Resolution #55 of 2020

BY ROLL CALL VOTE: SEVEN AYES. ONE NAY – LEGISLATOR MONTGOMERY. LEGISLATOR ALBANO WAS ABSENT. MOTION CARRIES.

Item #5h – Approval/ Conveyance of Tax Map No.: 83.72-1-68/ Town of Putnam Valley was next. On behalf of the members of the Physical Services Committee, Legislators Albano and Gouldman, Legislator Castellano moved the following:

Legislator Castellano explained that this will merge the parcel with the adjacent property owners' parcel. He stated that it would put the parcel back on the tax rolls which is a benefit for the taxpayers of Putnam County.

Legislator Nacerino concurred. She believed it is always good when there is a landlocked parcel that is not viable for any other use and it is contiguous with a property owner. She explained that the properties can be merged which would put the parcel back on the tax rolls. She believed this was a win win for everyone.

#### **RESOLUTION #75**

APPROVAL/ CONVEYANCE OF TAX MAP NO.: 83.72-1-68/TOWN OF PUTNAM VALLEY

WHEREAS, an unimproved parcel of real property identified as Town of Putnam Valley Tax Map No.: 83.72-1-68 was acquired by the County by Tax Deed, which was recorded in the Office of the Putnam County Clerk Office on October 1, 2019, in Liber 2130 at Page 311; and

WHEREAS, said property cannot be improved under existing zoning regulations; and

WHEREAS, Austin Koskinen Falls owns the adjacent parcel of property identified as Town of Putnam Valley Tax Map No.: 83.72-1-69; and

WHEREAS, Austin Koskinen Falls has offered to purchase Town of Putnam Valley Tax Map No.: 83.72-1-68 for the sum of \$1,000.00; and

WHEREAS, Austin Koskinen Falls has also agreed to merge Town of Putnam Valley Tax Map No.: 83.72-1-68 with his property; and

WHEREAS, the Putnam County Administration has reviewed said offer and recommends the acceptance of same; now therefore be it

RESOLVED, that pursuant to Section 31-8(B) of the Putnam County Code, the Putnam County Legislature approves the transfer of Town of Putnam Valley Tax Map No.: 83.72-1-68 to Austin Koskinen Falls for the sum of \$1,000.00, together with payment of all appropriate costs/fees, including but not limited to, Transfer Tax, Recording Fees, and County, Town, and School Taxes; and be it further

RESOLVED, that upon receipt of said monies, Town of Putnam Valley Tax Map No.: 83.72-1-68 shall be conveyed in an "as is" condition by quitclaim deed, which shall provide that it be automatically merged with Town of Putnam Valley Tax Map No.: 83.72-1-69; and be it further

RESOLVED, that the Putnam County Attorney is authorized to prepare said quitclaim deed, and the Putnam County Executive shall be authorized to execute said quitclaim deed on behalf of the County.

BY ROLL CALL VOTE: EIGHT AYES. LEGISLATOR ALBANO WAS ABSENT. MOTION CARRIES.

Item #5i – Approval/ Sale of County Property Pursuant to Chapter 31 of the Putnam County Code/ 20 Fair Street, Town of Carmel (White House) was next. On behalf of the members of the Physical Services Committee, Legislators Albano and Gouldman, Legislator Castellano moved the following:

Legislator Jonke stated that while he does support the sale of the property, he does not support the process. He stated that he was opposed to this in Committee when the property was listed without an appraisal. He stated that it was given to a real estate broker and the word on the street was that the neighbor wanted to buy the property. He stated that ultimately, that is the person who is in contract to purchase it. He again stated that he did not agree with the process and would be voting against it.

Legislator Sullivan stated that he was in favor of the sale because it is a property that the County has owned for years. It is off the tax rolls and we will sell it to a private individual which would put it back on the tax rolls. He stated that he was in favor of the County disposing of any assets that are no longer needed and can be put on the tax rolls to benefit the taxpayers. He believed this would improve the overall environment in the town. It is much better to have an occupied building that is going to be used for a business or some other purpose which will be improved by the owner. He did not believe the County needed to be in the real estate business of holding properties that are

vacant. He believed it was a great transaction when the County can sell them and get some money to use for other purposes.

Legislator Nacerino stated that she supports this. She explained that the building has been vacant for quite a few years and it was good to put back on the tax rolls. She did not believe we deviated from the process that we employee.

#### **RESOLUTION #76**

APPROVAL/ SALE OF COUNTY PROPERTY PURSUANT TO CHAPTER 31 OF THE PUTNAM COUNTY CODE / 20 FAIR STREET, TOWN OF CARMEL (White House)

WHEREAS, the County is the fee owner of a certain improved parcel of real property identified as 20 Fair Street, Carmel, New York (Carmel Tax Map Number 44.18-1-17), and which is further identified as Parcel B on filed map # 3216 (hereinafter the "Property"); and

WHEREAS, the Property is no longer needed for use by the County; and

WHEREAS, the County has continued to incur operation and maintenance costs associated with the Property; and

WHEREAS, pursuant to Resolution # 132 of 2020, the Putnam County Legislature authorized the County Executive to offer the Property for sale through the applicable Multiple Listing Service utilizing the services of a licensed real estate broker under contract with the County; and

WHEREAS, pursuant to Resolution # 167 of 2020, the Putnam County Legislature approved the Property to be initially offered for sale at \$250,000.00; and

WHEREAS, the Property has been listed on the applicable Multiple Listing Service; and

WHEREAS, the Putnam County Administration has entered into negotiations with a prospective purchaser for the Property; and

WHEREAS, the Putnam County Administration recommends the acceptance of the negotiated amount of \$210,000.00, and as further specified in the Contract of Sale, which is attached hereto and made a part hereof as Schedule "A"; and

WHEREAS, the Putnam County Legislature has reviewed said negotiated amount, now therefore be it

RESOLVED, that pursuant to the authority vested in the Putnam County Legislature in Section 31-4 of the Putnam County Code, the Putnam County Legislature approves the sale of the Property for such amount and upon such other terms and conditions as are contained in the Contract of Sale, which is attached hereto and made a part hereof as Schedule "A"; and be it further

RESOLVED, that the County Executive is authorized to execute the Contract of Sale for the Property, which Contract of Sale shall be in the form attached hereto and made a part hereof as Schedule "A"; and be it further

RESOLVED, that the County Attorney is authorized to take all necessary steps to complete the transfer of said property in accordance with the terms and conditions of the aforementioned Contract of Sale.

BY ROLL CALL VOTE: SEVEN AYES. ONE NAY – LEGISLATOR JONKE. LEGISLATOR ALBANO WAS ABSENT. MOTION CARRIES.

Item #5j – Approval/ Lease Agreement/ Building #5 Tilly Foster Farm was next. On behalf of the members of the Physical Services Committee, Legislators Albano and Gouldman, Legislator Castellano moved the following:

Legislator Castellano stated that the person that will lease the building is a Putnam County employee who works at the farm and handles the day-to-day operations. He believed it would be a benefit to have someone at the farm 24 hours per day. He stated that he will be providing security checks and notifying the appropriate individuals if anything occurs.

Legislator Montgomery explained that she sent a memo to the County Executive and the County Attorney regarding questions she had on this item. She stated that she did not agree with the response received from the County Attorney and stated that she did give her a call back. She questioned rentals of two (2) other buildings on the property. She explained that this property will be leased to a County employee and she believed that it appeared that we are going against our agreement with the Watershed Council and the easement agreement. She believed any housing on the farm was to be set aside for agricultural purposes and farmers. She questioned the process in selecting the tenant and the market value. She questioned the job description. She stated that she had nothing against this individual and was sure he worked very hard, however, she stated that if we were providing affordable housing for County employees, she questioned why this would not be opened up to all County employees. She believed there were many questions that were unanswered such as; fair market value, how the extra duties effect this employees benefits retirement pay, this individual is a Highway employee - how many hours is the Highway Department investing into Tilly Foster Farm, where is the chargeback for those hours and primarily does it comply with the Watershed Easement.

Legislator Montgomery made a motion to table this item until further information is received. There was no second. Motion fails.

Legislator Sullivan believed that having an employee on the farm was a valuable asset, to not only the County, but the residents of Putnam County who enjoy the farm. He stated that this employee does a tremendous amount of work on the farm working seven (7) hours per day, all day. He explained that this was a very difficult and demanding job. He stated that we were lucky to be able to get someone to do this work at a reasonable rate. He believed that having him there 24 hours per day was also very beneficial to the animals on the farm if anything were to happen. He stated that vacant buildings were not good for anybody. He believed that having the buildings occupied were a much better risk for the County and the overall pleasure of the community.

Legislator Nacerino believed that County Attorney Bumgarner stated in her memorandum today that Legislator Montgomery's outstanding questions, not that they were not answered, but were covered through the Physical Services Committee meeting, as well as in the lease agreement itself. She believed this was a nonissue matter because the Law Department certainly has authorized to effectuate this lease. She stated that it provides revenue to the County which presently has an unoccupied space. She stated that it will ensure the farm is being monitored by a County employee on the weekend and in the evenings. She stated that this lease is at no additional cost to the County and the employee is providing this service as part of the rental package. She stated that she would certainly support this lease.

Legislator Sayegh agreed that this was a good lease. She stated that there is a solid employee working on the farm that works with the Highway Department. She stated that the person will be there nights and weekends. She believed that it was a fair lease agreement. She stated that she was in favor of it.

Chairwoman Addonizio believed that the lease was an advantage to both the County and the employee. She stated that the employee is receiving a fairly priced lease and offering us the added security and oversight at the farm. She stated that County owned buildings are required by State law to be inspected, not by the town building department, but by our code enforcement official. She believed that Legislator Montgomery had a question regarding the certificate of occupancy (CO). She stated that COs are required for new buildings or if there were any construction changes that took place. She stated that Resolution #145 of 2019 was the approval of a lease agreement for Building #5, which is the same building we are discussing, and there was a unanimous vote, including Legislator Montgomery. She stated that the lease at that time was a collaboration with Columbia University and Cornell Cooperative Extension to develop a greenhouse project. She stated that there were no questions raised at that time regarding a CO. She stated that there have been no additions to the building since that lease that would require a CO.

Legislator Montgomery stated that Legislator Sullivan mentioned the tenant works seven (7) hours per day. She stated that it was not clear if he was working on the farm seven (7) hours per day. She stated that he also mentioned that the tenant was doing this for a reasonable rate. She stated that there is no rate before us or work agreement in the lease. She stated that Cornell Cooperative's use was cultural which is what our mandate is for this property. She explained that there was a lease approved last year when it was stated that they would be watching over the farm. She questioned how many people we had watching over the farm, what is their compensation and how does it effect their job description or benefit package. She stated that we do not even know what the market value is to rent it out. She stated that it was a shame that the town code enforcement officer does not have any oversight of this, and we can just rent without any oversight. She stated that she understands that the County does not need those approvals. She believed that by law we should make sure we are meeting our mandates from the Watershed Council as far as the conservation agreement that is on this property.

Legislator Sullivan clarified that he meant to say the person works seven days per week and not seven (7) hours per day. He believed the person worked more than seven (7) hours per day.

Chairwoman Addonizio called for a roll call vote.

Legislator Castellano offered the following resolution and moved its adoption:

BOND RESOLUTION OF THE COUNTY OF PUTNAM, NEW YORK, ADOPTED MAY 4, 2021, AUTHORIZING THE ACQUISITION OF VARIOUS PRE-K/EI VEHICLES AND RELATED EQUIPMENT; STATING THE ESTIMATED TOTAL COST THEREOF IS \$420,000; APPROPRIATING SAID AMOUNT THEREFOR; AND AUTHORIZING THE ISSUANCE OF \$420,000 SERIAL BONDS OF SAID COUNTY TO FINANCE SAID APPROPRIATION.

THE COUNTY LEGISLATURE OF THE COUNTY OF PUTNAM, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Legislature) AS FOLLOWS:

Section 1. The County of Putnam, New York (herein called "County"), is hereby authorized to acquire Pre-K/EI vehicles and related equipment. The estimated total cost of said class of objects or purposes, including preliminary costs and costs incidental thereto and to the financing thereof, is \$420,000 and said amount is hereby appropriated therefor. The plan of financing includes the issuance of \$420,000 serial bonds of the County to finance said appropriation, and the levy and collection of taxes on all the taxable real property in the County to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 2. Bonds of the County in the principal amount of \$420,000 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance said appropriation.

Section 3. The period of probable usefulness of the class of objects or purposes for which said bonds are authorized to be issued pursuant to this resolution, within the limitations of Section 11.00 a. 29 of the Law, is five (5) years.

Section 4. The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the County for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 5. Each of the bonds authorized by this resolution, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the County, payable as to both principal and interest by general tax upon all the taxable real property within the County.

The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 6. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds having substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and Sections 50.00, 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the County Legislature relative to authorizing bond anticipation notes, or the renewals thereof, and relative to providing for substantially level or declining annual debt service, and prescribing the terms, form and contents, and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said notes, as well as to executing agreements for credit enhancements, are hereby delegated to the Commissioner of Finance, the chief fiscal officer of the County.

Section 7. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of such resolution, or a summary thereof, are not substantially complied with.

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the constitution.

Section 8. This bond resolution shall take effect upon the approval of the Putnam County Executive, and the Clerk of the County Legislature is hereby authorized and directed to publish the foregoing resolution, in summary, together with a Notice attached in substantially the form prescribed by §81.00 of the Law in "The Putnam County Courier," "The Putnam Press," and "The Putnam County News & Recorder," three newspapers, each having a general circulation in the County and hereby designated as the official newspapers of the County for such publications.

Item #5L – Approval/ Bond Resolution/ Acquisition of Various Vehicles And Heavy Equipment For The Highway Department/ \$500,000 was next. On behalf of the members of the Physical Services Committee, Legislators Albano and Gouldman, Legislator Castellano moved the following:

Legislator Castellano stated that the list of equipment being purchased were: one (1) Gradall truck, three (3) four-wheel drive pickup trucks, one (1) crew cab pickup, one (1) pickup truck with plow and one (1) brine tank. He stated that this will be a savings in the long run for Putnam County taxpayers.

Legislator Montgomery stated that she supports infrastructure projects and improvement. She stated that she did not understand why we needed to bond for them all the time. She believed that if we were better fiscal managers, we would not have to bond for this and would have the money to purchase this equipment. She stated that she would not support this.

Legislator Sayegh stated that she would support this. She believed that we were being fiscally prudent by balancing the amount over several years as opposed to over one (1) year, especially when we will utilize these vehicles for a number of years. She believed it

was better to bond and to use the County's good Double A bond rating, bonding at a lower rate. She believed this was the best way to budget for these large purchase items.

Legislator Nacerino stated that this was not a matter of not having the funds. She believed that it was a matter of being fiscally responsible by bonding for this equipment. She stated that we will be bonding over its useful life of 15 years. She stated that interest rates are low. She believed this was the prudent way to move forward.

She stated that the Putnam County Historian's office has been working diligently to identify more black history in Putnam County. She stated that, with the help of our P.I.L.O.T. program, two (2) other locations will also have historical markers to identify the historical significance of black history in Putnam County.

Legislator Nacerino stated that it is wonderful that we received an outside donation for this project. She stated that this is a wonderful recognition.

APPROVAL/ GRANT APPLICATION/ BUREAU OF EMERGENCY SERVICES/ FY2021 EMERGENCY MANAGEMENT PERFORMANCE GRANT (EMPG) PROGRAM

WHEREAS, Section 5-1(D)(1) of the Putnam County Code requires Legislative approval of all grant applications and renewals that require County matching funds; and WHEREAS, the Bureau of Emergency Services requested permission to apply for the FY2021 Emergency Management Performance Grant (EMPG) Program funding in the amount of \$41,401; and

WHEREAS, the funding is provided by the U.S. Department of Homeland Security, Federal Emergency Management Agency (FEMA); and

WHEREAS, the New York State Division of Homeland Security and Emergency Services (DHSES) will administer this funding on behalf of FEMA; and

WHEREAS, the performance period for this grant is 36 months, from October 1 2020 to September 30, 2023; and

WHEREAS, the grant application deadline is April 30, 2021; and
