## ORGANIZATIONAL MEETING OF THE PUTNAM COUNTY LEGISLATURE HELD VIA AUDIO WEBINAR PURSUANT TO CHAPTER 417 OF THE LAWS OF 2021

## <u>Tuesday</u> January 4, 2022 7:00 P.M.

The meeting was called to order at 7:03 P.M. by County Clerk Michael Bartolotti who requested Legislator Jonke to lead in the Pledge of Allegiance. County Clerk Bartolotti then requested Legislator Addonizio to lead in the Legislative Prayer. Upon roll call, Legislators Montgomery, Gouldman, Addonizio, Nacerino, Albano, Jonke, Castellano, Sayegh and Sullivan were present. Also present was Legislative Counsel Firriolo.

Item #4 – Appointment/Chair/Putnam County Legislature was called first. County Clerk Bartolotti requested nominations from the floor for Chair of the Legislature.

Legislator Addonizio made a motion to nominate Legislator Sullivan as Chairman; seconded by Legislator Albano.

Legislator Albano stated that Legislator Sullivan is a Certified Public Accountant. He explained that Legislator Sullivan has brought a wealth of knowledge and experience to the Legislative body.

Legislator Addonizio stated that as Chair of the Legislature for the past two (2) years, we have faced many challenges during the COVID-19 pandemic. She stated during that time Legislator Sullivan served as Deputy Chair. She stated that he has strong community ties and serves on the Rotary, Knights of Columbus and the Chamber of Commerce. She stated that he is a local business owner for over 20 years. He is a Certified Public Accountant and holds an MBA. She stated that ne served on several Legislative Committees and has Chaired the Rules Committee for the last two (2) years. She believed that his knowledge and experience would benefit all residents of Putnam County.

County Clerk Bartolotti asked if there were any other nominations.

Legislator Montgomery made a motion to nominate herself.

County Clerk Bartolotti stated seeing no second on Legislator Montgomery's motion, he asked for a roll call vote on the first nomination for Legislator Sullivan.

Legislator Montgomery asked for discussion. She stated that she was surprised that there were no other nominations. She explained that she had concerns about moving this nomination forward based on his past behavior during meetings. She believed he would not be a good fit as Chair, based on her own personal experience of how she has been treated by him. She was especially concerned about behaviors during executive sessions and was uncertain how things discussed were released to NBC. She believed that the behavior was politically motivated. She stated that she brought items forward to him, as Chair of the Rules Committee, which have been completely ignored. She stated that her concern was that items being brought to him as Chair of the Legislature would be ignored. She believed the people of Putnam County deserved stronger leadership.

Legislator Castellano stated that Legislator Jonke has been on the Legislature for five (5) years and has served as Chairman on both the Personnel Committee and the Protective Services Committee. He stated that Legislator Jonke has done a fantastic job and he looked forward to working with him as Deputy Chair of the Putnam County Legislature.

Legislator Albano stated that he would be honored to second that motion.

Chairman Sullivan stated seeing no further nominations, he requested a roll call vote on the nomination for Legislator Jonke.

She explained that she was happy to support this appointment.

Item #29 – Confirmation/ Designation of Jail Chief Medical Officer was next. Chairman Sullivan made a motion to move the following; seconded by Legislator Albano.

Legislator Montgomery explained that we received two (2) letters from the NYS Department of Health Commissioner Howard Zucker, both stating that the Putnam County Health Commissioner dedicate 100% of his time being the Health Commissioner. She believed this appointment did not follow that rule. She stated that it is a State law and we also have it in our County Charter. She believed, especially during this pandemic, it was critical to the public's health in Putnam County that our Health Commissioner dedicate 100% of his duties being the Health Commissioner and not to hold other titles as; Coroner, Coordinator of Coroners and Jail Physician. She believed there was an extensive outbreak currently at the Jail which she believed takes up a lot of his time. She stated that we are also seeing the highest infection rate since the beginning of this pandemic in Putnam County. She stated that we still have a long way to go in protecting public health. She believed that we need a Health Commissioner whose duties are 100% devoted to the Health Department and public health of Putnam County and not the Jail.

Legislator Albano stated that Dr. Nesheiwat has given more than 100% to his duties as Health Commissioner. He stated that he does a fantastic job and has also been able to perform his duties as Jail Chief Medical Officer. He stated that he could not think of a better candidate and totally supported this.

Legislator Sayegh stated that this has been vetted year after year. She stated that Dr. Nesheiwat devotes 100% of his time at the Jail when he is supposed to be there, and he devotes 100% of his time as Health Commissioner for the time he is supposed to be there. She stated that he is a very well qualified respected physician. She believes 100% in him and his abilities.

Legislator Montgomery stated that she was not speaking about the Commissioner's abilities. She did not understand how a person could dedicate more than 100% of their time when 100% of time is all you have. She stated that we are in the middle of a pandemic, and it was not wise, and it is not good public health practice. She stated that we have two (2) letters from Howard Zucker stating that the Health Commissioner is to dedicate 100% of his time being the Health Commissioner. She stated that we are violating the County Charter and the State health law.

Legislator Albano stated that the letter states he should devote full time to that position; not 100%. He stated that nobody works 24 hours per day, although Dr. Nesheiwat does a good job at coming close to that.

Legislator Castellano stated that Dr. Nesheiwat does a fantastic job. He believed that we discuss this every year. He stated that PrimeCare has proposed that Dr. Nesheiwat continue to act as the Chief Medical Officer for the Jail. He believed that this was a great thing to do, and he was happy to support it.

Chairman Sullivan stated that Dr. Nesheiwat gives 100% of his time to the residents of Putnam County in protecting them and making sure that they are safe and healthy. He believed that we were at the end of the pandemic and the beginning of an endemic.

WHEREAS, PrimeCare has proposed Dr. Michael Nesheiwat to continue to act as the Chief Medical Officer for the Jail; now therefore be it

RESOLVED, that the Putnam County Legislature hereby designates of Dr. Michael Nesheiwat to act as the Chief Medical Officer for the Putnam County Corrections Facility, for a period of one (1) year, said term to expire December 31, 2022.

WHEREAS, recommended salaries and job specifications were provided by the Personnel Department based on scope of duties and compensation from surrounding counties; and

WHEREAS, in addition to salaries and benefits, funding will be provided for four (4) L-shaped desks with built in cubicle walls and file drawers to set up a four-person workspace in the Putnam County Department of Health; and

Item #33 - Approval/ Budgetary Transfer (22T002)/ Commissioner of Finance/ EMS Contract/ Ambulance Services Per Awarded Request for Proposal (RFP) was next (Approved at December Protective Services & Audit Mtgs). On behalf of the Protective Services Committee, Chairman Sullivan moved the following:

Legislator Gouldman stated that he would be voting no on this. He stated that he has had discussions with the Putnam Valley Ambulance Corps and a few other Ambulance Corps. He stated that they do not believe the current situation with Ambulnz is the best move the County could make. He explained that his "no" vote sends a message that some individuals are not happy with the situation.

Legislator Montgomery stated that she has not heard from any Ambulance Corps or first responders yet that this is a good thing. She stated that she is still receiving comments from the participating agencies who will be affected by this that they are not happy. She understands that this proposal could be good for the County, could save the County money and could be a better service, however we just do not know. She stated that she trusts the people that perform this type of work and know what is good for their agencies. She stated that the primary reason she would be voting no was that she still did not have a copy of the contract which she has requested several times. She explained that the agencies do not know how this proposal will affect their operations, budgets, or town budgets. She believed there were too many unknowns. She stated that she would still like a copy of the contract.

Legislator Albano stated that the contract was reviewed by several different departments. He stated that during the Audit Committee meeting there were a lot of questions and concerns addressed which he was pleased were answered. He stated that he was hopeful that it was a good contract. He stated that we are not approving any contracts as that falls under the purview of the County Executive's office. He explained that we are approving what we are obligated to pay on the contract. Legislator Nacerino stated that as the liaison to the Fire Advisory Board, she was well aware of the concerns that have been brought forth. She stated that the contract has taken effect January 1<sup>st</sup> and she hoped that moving forward Ambulnz will prove to alleviate those concerns. She stated that she knows they have met with the Town of Patterson, along with other municipalities, to alleviate some of the current concerns brought forth.

There was no other business submitted to the meeting.

Item #36 – Recognition of Legislators

Legislator Montgomery clarified that Legislator Albano was correct that the letter from Harold Zucker does say full time, not 100%. She stated that the letter also states that the Commissioner must dedicate full time with no other assignments. She explained her concerns about Dr. Nesheiwat holding other titles, especially during a public health crisis. She congratulated Legislator Sullivan on being appointed as Chairman of the Legislature. She hoped that they could work through many of the difficulties they have had, and she hoped they could work together, despite their differences, for the people of Putnam County. She hoped that Chairman Sullivan would consider her qualifications when determining Committee assignments and she asked if she could be part of any discussions that take place while making that decision. She stated that she would like the opportunity to serve on the Health and Protective Committees, and she provided an explanation of her many qualifications. She believed that she could serve the Legislature well by serving on these Committees.

Legislator Albano believed that Legislator Montgomery's opinion on the Health Commissioner's job was inaccurate. Legislator Albano quoted the Putnam County Charter, Section 10.04(d) "the Commissioner/Public Health Director shall serve on a fulltime basis and shall not be employed nor engage in any private practice in their field of expertise." He stated that this has been reviewed carefully by our Law Department and everything is in accordance with how it should be. He stated that his appointment is clearly permissible. Legislator Nacerino congratulated Legislator Sullivan on becoming Chair of the Legislature and Legislator Jonke on becoming Deputy Chair. She wished everyone a happy and healthy new year. She looked forward to working with her colleagues in 2022 and recognizing that our differences of opinions must be mutually respected by all working in a cohesive manner moving forward.

Legislator Addonizio congratulated Legislators Sullivan and Jonke on their appointments as Chair and Deputy Chair. She also congratulated Legislators Nacerino, Castellano and Montgomery on their re-elections. She stated that she looked forward to a productive year.

Legislator Gouldman thanked Legislator Addonizio for serving as Chair of the Legislature for the last two (2) years, and as Deputy Chair prior to that. He stated that she did a great job, especially during the COVID-19 pandemic with holding meetings via audio webinar. He also congratulated Legislators Sullivan and Jonke on their appointments as Chair and Deputy Chair.

Legislator Sayegh concurred with Legislator Gouldman and thanked Legislator Addonizio for serving the past two (2) years as Chair and Legislator Sullivan as Deputy Chair. She stated that the past two (2) years have been difficult to navigate through COVID-19 with on-line meetings. She stated that Legislator Addonizio did a great job, and she appreciated her leadership throughout the pandemic. She welcomed and congratulated the new Chairman, Legislator Neal Sullivan and Deputy Chairman, Legislator Paul Jonke. She looked forward to a great year of good things to come in Putnam County. She stated that the Putnam County Department of Health and the NYS Department of Health have exceeded their capacity to perform contact tracing for all people who have tested positive for COVID. She explained that there were 2,000 people in Putnam County who have tested positive. She stated that Putnam County residents who test positive are asked to self-isolate and to notify their contacts. Those who have been exposed to someone who tested positive are being asked to self-quarantine. She stated that, in speaking with the NYS Department of Health today, they believed Putnam County was being pro-active. She asked everyone to please be safe as we make our way through the omicron spike which she hoped would be over at the end of January.

Chairman Sullivan thanked his colleagues for their support. He looked forward to a tremendous 2022. He thanked Legislator Addonizio for her leadership and guidance serving as Chair over the past two (2) difficult and unprecedented years. He congratulated Deputy Chair Jonke. He welcomed Sheriff Kevin J. McConville in becoming part of the Putnam County team. He stated that he looked forward to working closely with him over the coming year. He wished everyone a healthy and safe 2022.

There being no further business, at 8:10 P.M., Chairman Sullivan made a motion to adjourn; seconded by Legislator Sayegh. All in favor.
